## I. STATEMENT OF PURPOSE

10:30 p.m. – 10:45 p.m.	Corporate Prayer by House
11:00 p.m.	Lights Out

## III. APPLICATION PROCESS

The applicants are required to submit a personal statement in which they are asked to describe their burden related to the third year of training. The application also includes an Elder's Comments. The deadline for submission of applications will be announced. Personal interviews with applicants are also planned. It is anticipated that any practical issues or limitations can be addressed in the fellowship throughout this process, but those trainees with feeling to participate in FTTA-XB are encouraged to apply. An application does not guarantee acceptance into the program, neither does it require the applicant to attend.
