

FULL-TIME TRAINING IN ANAHEIM

STATEMENT OF FINANCIAL RESPONSIBILITY

The United States Bureau of Citizenship and Immigration Services (USCIS) requires all educational institutions in the U.S. to obtain evidence of financial resources from any applicant who is not a U.S. citizen or Permanent Resident. This must be submitted **before** a Certificate of Eligibility (Form I-20) can be issued. Therefore, the Full-time Training in Anaheim (FTTA) cannot issue an I-20 to applicants who have not submitted this confirmation form with all the appropriate required documentation.

If the applicant is a single, full-time student with no dependents, the applicant must certify that he or she is able to pay a minimum of **\$20,000** U.S. dollars for each year of study in the FTTA. This amount, however, does not apply to applicants who are married or have dependents. Applicants with these or other special circumstances should consult with the FTTA regarding modification to the minimal payment requirement. Regardless, your financial evidence should reflect adequate funds to cover the amount as indicated.

Then, depending on your financial arrangement, you or your financial sponsor(s) should complete one of the following pages (pages 3-5). Once completed, please submit the Affidavit of Financial Support forms and other documentation as specified on the I-20 Applicant Cover Page. **Please do not use electronic signatures.**

Self-sponsorship requires evidence of financial resources for the duration of **one year of study** in FTTA. **You**, as the **FTTA applicant**, must complete the Affidavit of Financial Support - Statement of the Self-Supporting Applicant (page 3). You are required to also submit copies of official monthly bank statements, in your name, indicating financial ability in U.S. dollars. All foreign documents must include English translation.

If a family member or other individual **sponsor** will be proving your financial ability to pay, please have the **sponsor** complete the Affidavit of Financial Support - Statement of the Sponsor or Parent(s) (page 4). They should also submit copies of official monthly bank statements, indicating financial ability in U.S. dollars. All foreign documents must include English translation.

3. From sponsoring church

(directions: also submit page 5 and 6)

If supported by your church, the **sponsoring church** is required to complete the Affidavit of Financial Support - Statement of the Sponsoring Church (page 5). Copies of official monthly bank statements indicating financial ability should also be submitted. All foreign documents must include English translation.

Please also attach an additional letter of support. The letter should be printed on the church’s letterhead, signed by the elder(s), and if available, stamped with the seal of the church. The letter of support should clearly communicate that the applicant is a bonafide member of the church and list the number of years that the applicant has been a member. The letter should include the duration of the sponsorship, what expenses will be covered, and the total amount the applicant will be given for one year of study. The letter should make clear that the applicant has been recommended to represent the sponsoring church to attend the FTTA. Page 6 provides a sample copy.
